I am a qualified elector of the DDA because (choose one – required):

\_\_\_\_\_ [Resident] I am a citizen of the United States, a resident of the State of Colorado, eighteen years of age or older, and whose primary dwelling place is within the boundaries of the DDA.

\_\_\_\_\_ [Landowner] I am an “owner in fee” of an undivided interest in real property or an improvement permanently affixed to real property within the boundaries of the DDA and am eighteen years of age or older. An “owner in fee” includes a contract purchaser obligated to pay general taxes, an heir, and a devisee under a will admitted to probate. An “owner in fee” does not include a contract seller of property where the purchaser is deemed to be the owner in fee.

\_\_\_\_\_ [Lessee] I am a holder of a “leasehold interest” in real property within the boundaries of the DDA and am eighteen years of age or older. A “leasehold interest” does not include a license or a mere contract right to use real property within the DDA.

\_\_\_\_\_ [Entity Representative] I am the representative of a Landowner or Lessee which is not a natural person who has been designated by official action of the Landowner or Lessee to cast its ballot and am eighteen years of age or older.

I am requesting a mail ballot for the Littleton Downtown Development Authority Special Election mail ballot election to be held on November 8, 2022 because: (choose one - required):

Requests for mail ballots may be made after October 31, 2022 up to and through election day for pick-up. Return completed form no later than November 8, 2022 to receive a ballot.

Voted ballots must be received no later than 7:00 p.m. on November 8, 2022.
